## **Environmental Policy**

- Ensure that employees will be accountable for implementing this policy through training and communication of environmental issues.
- Communicate the Company policy to customers and suppliers/sub-contractors in order to promote its implementation
- Continually review and monitor the Company's environmental performance in order to set achievable targets on which there will be endeavour to improve
- Provide appropriate resources to meet the implications and implementation of the policy
- Provide the necessary information to enable all equipment and materials to be properly used, stored, and disposed of and for staff to undertake work to avoid unacceptable effects on people and the environment
- Require suppliers of goods and services to operate to high environmental standards
- Eliminate unnecessary and inefficient use of company owned facilities and vehicles and ensure that public transport is used for business travel whenever possible
